WISCONSIN RIVER POWER COMPANY REQUEST FOR DANGER/HAZARD TREE REVIEW

Landowners may request Wisconsin River Power Company (WRPCO) to review danger or hazard trees on its owned property for removal. To initiate the WRPCO review process, fill out the attached application and include the information below.

Wisconsin River Power Company (WRPCO) will only cut and down tree(s) that, by WRPCO standards, are considered dead, diseased or dangerous. An example of a tree that meets the criteria would be a dead or diseased tree that creates a danger to human health or could damage personal property. WRPCO's goal is to maintain the natural character of the SCA and will not cut a tree that is dead if the tree does not pose a danger to human health or personal property.

If the tree(s) meet the criteria, WRPCO employees and/or contractors of WRPCO will cut and down the tree(s) into manageable sections. The sections can then be removed by the adjacent property owner by hand or left in place.

No trees alive, dead, or diseased are to be cut and no motorized vehicles are allowed to be used on WRPCO property other than WRPCO employees and/or its contractors.

- Mark the tree(s) with ribbon, not paint, which you believe needs to be cut and downed because of a dangerous situation.
- Provide a picture of the tree(s).
